Only those tenderers who are willing to accept all the terms & conditions of this detailed tender call notice need to submit the tenders.

Tenders not accompanied with the EMD and Paper Cost as specified in tender call notice shall not be considered at all.

Rate quoted by the contractor shall be excluding GST and LabourCess. The GST and Labour Cess as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice. The prevailing rate of GST and LabourCess on the gross amount of bill will be deducted from the contractor bill as tax deduction at source (TDS) as per rule.

The successful bidder who has quoted less bid price/rate than the estimated cost put to tender shall have to furnish additional performance security (APS) in the shape of FDR/NSC/Post Office Saving Bank Account/Post Office Time Deposit Account/KissanVikashPatra in favour of the Managing Director, OSCDC,Bhubaneswar (as specified intender call Notice) from any Nationalized/Scheduled Bank in India within 7 (seven) days of issue of letter of Acceptance (LoA) by the Executive Engineer (Agril.), Directorate of Horticulture, Bhubaneswar to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further proceeding of blacklisting shall be initiated against the bidder.

All the rates & prices in the tender shall cover all taxes viz-Central or State Sales Tax, Octroi, any other local taxes, ferry, tollages charges & royalties & any other charges.

2. INSTRUCTIONS TO TENDERERS

2.1 Eligibility Criteria

The eligibility criteria for participation in this tender are given below. The tenderer (s) should go through these eligibility criteria before purchasing the tender documents. Tenderer (s) not fulfilling the eligibility criteria and submitting the tender, can do so at their own risk, as the tender will summarily be rejected.

- (1) The Contractor should have previous work experience of having completed a single Building (in case of building)costing at least one work of 80% of the Tender amount or at least two works each of 60% of the Tender amount for buildings costing more than 20Lakhs, as mentioned in column 3 of above table. Road, bridge, compound wall, building repairing works, canal works, any other non-building work will not be considered as experience for bidding in new building work.
- (2) The intending tenderer(s) should have not abandoned any work of similar nature nor should their contract have been rescinded during the last five years.
- (3) The intending tenderer(s) should have the valid Registration Certificate as on date, of the required class as mentioned in Col-7 of the Table in TCN.
- (4) The intending tenderer(s) should have up to date valid ITCC, (PAN) GSTIN.
- (5) Graduate Engineers and Diploma Holders registered under concessional scheme are not sub divided as SC/ST, & other categories. Hence facilities availed by SC/ST persons are not allowed to an Engineering Contractor belonging to SC/ST as per letter No.49277 date 21.12.2005.
- 2.2 Filled up sealed tenders in complete shape will be received as per TCN through online.
- 3. Tender containing extraneous conditions not covered by the conditions here-in-before & here-inafter provided & quoting rates on units different from those prescribed in the tender schedules will
 be liable for rejection. No Tenderer will be permitted to furnish tender in their own manuscript
 form.
- 4. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tender papers
- Any request from the tenderer in respect, of additions, alternations, modifications, corrections, etc. or either terms & conditions or rates of his/her tender after opening of the tenders will not be considered.
- 6. The successful tenderer shall make his/her own arrangement for all materials T&P machineries required for satisfactory completion of work in time. Unless otherwise specified in the conditions or contract.
- 7. By submitting a tender for the work, a tenderer will be deemed to have satisfied himself by actual inspection of the site & locality of the work about the quality & availability of the required quantity of materials, medical & labour & food stuffs etc.
- 8. The detailed list of successful bidders against each work will be displayed in the Office Notice Board. Acceptance letter of the tender will be intimated to the successful tenderer in writing through e-mail. The successful bidder can collect the letter of acceptance from this office within 7 (Seven) days from the date of declaration of successful bidder on the notice board. The incidental items mentioned here in any only indicative & not exhaustive. No extra payment or claim will be admissible on these grounds.
